

Rules and Registration



- 1) Tournament officials reserve the right to cancel this tournament due to extreme weather conditions. No refunds will be made.
- 2) 5 fish limit per boat. Largemouth, Smallmouth, and Spotted Bass only will be weighed. All fish 12 inch on Golden Rule. No dead fish.
- 3) Two contestants per boat only. On the morning of the tournament, each boat team will be assigned a boat number by order of entry fee payment and registration. Keep this boat number card in your possession. It will be used for take-off, check-in, and weigh-in identification. All boats must present their boat number, and leave from and return to the designated check in point.
- 4) No trolling allowed. Artificial bait only. No fishing within 50 yards of an anchored boat.
- 5) If late to weigh-in a deduction of 1 pound a minute from the final weight will be made, up to 15 minutes.
- 6) Safe and courteous boating practices must be observed at all times. All contestants must wear PFD's any time the motor is in operation. Each boat must meet all US Coast Guard regulations. No alcohol or illegal drugs permitted.
- 7) Fish must be kept in live well. Any fish that appears to be in a questionable condition will not be weighed.
- 8) At least one team member must attend a meeting at **5:45am** on the morning of the tournament.
- 9) Entries mailed in must be received by April 6, 2012. Mail a signed copy of the application with a check for \$100.00 (+\$10 optional big fish pot) to City of Athens P.O. Box 1089 Athens, AL 35612. Make all checks payable to **City of Athens**.
- 10) Late entries of \$125.00 per boat will be accepted on the morning of the tournament at the ramp from 4:30am-5:30am. Only cash will be accepted on the day of the tournament.
- 11) **Liability Release:** By signing this agreement, I hereby release all tournament officials, sponsors and all persons involved with the operation of this tournament, for any or all damages, claims, costs, or expenses relating to any injury of any persons or any property damage which I may sustain or cause by any reason of participation or in connection with this tournament.
- 12) **Verification of Boat Owner/Operator Liability Insurance:** I further state that I have and will maintain liability insurance on the boat I will use in this tournament.
- 13) **Reading and Understanding:** I confirm by my signature below that I have read and agree to abide by all these rules and agreements as stated.
- 14) All winners will be subject to a polygraph test.
